IT PROVIDES REMOVAL DEFENSE LEGAL SERVICES FOR ALL LOW-INCOME NON-CITIZENS IN THE BAY AREA AND CENTRAL VALLEY WHO HAVE SOME FORM OF VIABLE RELIEF AVAILABLE.
