IT PROVIDES REMOVAL DEFENSE LEGAL SERVICES FOR ALL LOW-INCOME NON-CITIZENS IN THE BAY AREA AND CENTRAL VALLEY WHO HAVE SOME FORM OF VIABLE RELIEF AVAILABLE. THE PROGRAM UTILIZES STAFF ATTORNEYS TO SCREENS ELIGIBLE CANDIDATES, BOTH IN IMMIGRATION DETENTION AND OUT FOR POTENTIAL RELIEF, BOND OPPORTUNITIES, DEFENSES TO DEPORTATION, AND THEN PROVIDES HIGH-QUALITY FULL-SCOPE DEFENSE FROM START TO FINISH.
